All Stakes will be single course without birdfield, except Open Gun Dog and Amateur Limited Gun Dog will have a birdfield with retrieve in bird field. Shooting to be done by Official Gunners. A blank cartridge will be fired in Open Puppy at the discretion of the handlers.

Quail and/or Chukar and/or Pheasant will be released in all stakes.
